1. Application & Limitation

- 1) The flexible hoses are to be installed in clearly visible and readily accessible locations.
- 2) The number of flexible hoses is to be kept to minimum and to be limited for the purpose stated on the certificate.
- 3) The certificate is valid for the specific assembly of hose and coupling type as specified, assembled and delivered directly by the Manufacturer.
- 4) Flexible Hose assemblies are not to be installed where they may be subjected to torsional deformation (twisting) under normal operating conditions.

 5) The flexible hoses in high pressure fuel oil injection systems are not to be accepted.

 6) The installation and maintenance of the flexible hose assemblies are to be in
- accordance with the manufacturer's instructions and use limitations with particular attention to the following.
 - Orientation
 - End connection support (where necessary)
 - Avoidance of hose contact that could cause rubbing and abrasion
 - Minimum bend radius

2. Individual Product Cert. and Drawing Approval Requirement

- 1) Individual Product Certification is required.
- Mechnical joints other than bolted flanges, welding joint between pipings are to be separated from this approval.

 - Pressure rating
 - Temperature rating
- 2) Where a flexible hose assemblies are made up of items from different manufacturers, the components are to be clearly identified and traceable to evidence of prototype testing.
